Sky blue Papers Private Limited (hereinafter referred to as “the Company”) is a company limited by shares incorporated on 3rd March, 2014 by Mr. Ashwani Soni and Mr. Sahil Arora as private limited company unit in manufacturing of PE coated paper (Sheets & Reels) papers cup, bottom papers cup, laminated papers, printed paper cup etc. under the provisions of the Indian Companies Act, 1956.

On 17th May, 2018, the National Company Law Tribunal, Chandigarh Bench, in Company Petition No. CA No. 02/2018 IN CP (IB) No. 09/Chd/CHD/2017 ordered for liquidation of the Company. Mr. Prem Kumar Garg holding IBBI **Regn. No. IBBI/IPA-001/IP-P00346/2017-2018/10647** has been appointed as the Liquidator of the Company.

The Company is the manufacturer/exporters/service provider/whole sale supplier of paper cups, PE Coated sheets, papers blanks, bottom paper cups, paper cups of all sizes and shapes. The Company is presently in liquidation and business operations of the company are almost closed since April, 2017.
